- 1. Vendor space is NOT reserved until the application, payment, proof of insurance and tax forms are received in the Fair Office. Failure to comply or cancellation after July 10<sup>th</sup> will result in forfeiture of payment. Food vendors must guarantee and provide a \$1,000,000 Certificate of Insurance wherein Boundary County Fair Board and its agents are additional named insured on a broad form comprehensive general liability endorsement or commercial general liability. Please provide a menu with prices. Each menu will be reviewed in order to avoid duplication of food items.
- **2.** Set-up time is Monday, August 17<sup>th</sup> and Tuesday, August 18<sup>th</sup>, 9:00 AM until 7:00 PM. All food concessions must be set up by 11:00 AM on Wednesday, August 19<sup>th</sup>. Cargo trailers will be permitted on grounds during set-up but must be removed to designated parking area during the fair. Fair closes at 9 PM daily. Take-down is Saturday, August 22nd, after 7:00 PM and Sunday, August 23<sup>rd</sup> until 11:00 AM. **NO EARLY TAKE-DOWN as this will result in forfeiture of the included \$25 deposit.**
- **3.** After-hours security watchmen are provided, however, each vendor is responsible for securing their vendor space by removing valuables at night. The Boundary County Fair Board is not responsible for loss or damage of vendor items.
- **4.** All fair rules and regulations must be followed. Selling of products, raffle tickets, drawings, distribution of any materials, etc is permitted only within your vendor space. The Boundary County Fair Board has the right to: reject any product, item or material to be sold or given away if deemed detrimental to the fair and inspect premises at any time to ensure proper food handling practices. Failure to comply can result in being asked to vacate and forfeiture of fees. Panhandle Health will inspect vendor areas on Thursday, August 20<sup>th</sup>.
